Ge eba ga se o tšhwe o thome go faela ka eFiling, ngwadiša go www.sarsefiling.co.za O hloka go ba o ngwadišitše go eFiling gape o be le mohuta o tee wa motšhelo wo o diragadišwego go profaele ya gago ya eFiling, gore o kgone go diriša tirelo ya TCS.

2 Diragatša tirelo ya gago ya Maemo a Obamelao ya Motšhelo

O hloka fela go diragatša Maemo a gago a Obamelao ya Motšhelo ga tee, gomme e tla dula e šoma.

4 Kgopela PHINI go eFiling

Go kgopela PHINI leba go "My Compliance Profile":

- Kgetha boikgethelo bja Maemo a Obamelao ya Motšhelo
- Kgetha TCS bakeng sa yeo o ratago go e kgopela. O tla ba le dikgetho tše di latelago:
 - » Maemo a mabotse dipukung
 - » Thendara
 - » Dipušetšo tša Dipeeletšo tša Naga ya ka ntle (batho ka noši fela)
 - » Bofaladi (batho ka noši fela)
- Tlatša Kgopelo ya Maemo a Obamelao ya Tefelo ya Motšhelo (TCS) gomme o e romele go SARS

PIN ya gago e ka fiwa le semetsing ka SMS goba ka emeile ge eba merero ya gago ya motšhelo e eme gabotse.

Na nka dira eng ge eba "My Compliance Profile" ke e KHUBEDU?

Boikgethelo bja 1:

Tshela sešupi sa maemo "Non-compliant" go eFiling go hwetša tshedimošo ennge ka ga ka fao o ka lokišago maemo a gago a obamelao le go tšea magato ka fao go hlokegago.

Boikgethelo bja 2:

Ge eba ga o dumelelane, gomme o rata go tlotla maemo a gago a obamelao ya motšhelo, kgetha "Challenge Status" mo fase ga sekirini sa "My Compliance Profile".



Na ke mang yo a tiišetšago maemo a gago a obamelao ya motšhelo?

Go ka ba le mabaka ao motho yo mongwe (motho ka noši goba khamphani enngwe goba setheo sa mmušo) ba nyakago go tiišetša maemo a gago a obamelao ya motšhelo bakeng sa kgopelo ya thendara, bakeng sa maemo a mabotse - go tiišetša ge eba merero ya gago ya motšhelo e maemong a mabotse le SARS, goba bakeng sa putseletšo ya Dipeeletšo tša Naga ya ka ntle.
